I refer to the following video clips from our discussion on 21 April 2023 and your insistence that we follow the advertised 101 channels in relation to our report of a crime. I would also refer you to our statement that we had reported crimes through 101 that were not being investigated.

However, we have not heard from you in relation to this information hence this communication exactly one month later. You will note from the following video clip that you took my card and placed it in your high viz top, you will find my contact details on the card.....

With regards to this particular video, what follows is my initial 101 report of the probable unlawful killing of Glynneath residents through Neath Port Talbot Council malpractice. The occurrence number for the report is:

Please also note that this report was 2 years and 4 days previous to our discussion at the Glynneath Town Hall. The failure of South Wales Police to address criminal activity at the Neath Port Talbot Council and Natural Resources Wales in relation to environmental crimes reported to them is almost certainly causing the death of Glynneath residents. I would urge you to consider doing your job to safeguard against further contamination deaths at the Heol y Glyn landfill site.
