Dear DS Peach

In our last communication chain you stated that you would get back to me with regards my complaint about Michael Pugh, however I did not hear back from you. To update you on my complaint and to escalate it to a potential murder enquiry, I would like you I would like to provide you with the following informatuion.

Mr Pugh left the council a few months later after his election following an internal email chain about me at the Glynneath Town Council referencing child abuse and murder at the council. The complete email chain is being withheld from me as is the process of the FOI and I made a representation at the Glynneath Town Council identifying this which can be found on YouTube.

Councillor Pugh then left Glynneath and moved to Llanelli.

I now refer you to the missing Glynneath Town Councillor Roger Simons (AKA Roger the Grass) who went missing last May and whose body is yet to be found. Roger was a political ally of our group and well known for informing the authorities of wrongdoing, my last conversation with Roger was on the day before the most recent election, it was about about the likleyhood of the May election being fixed considering that I have identified endemic corruption at the NPTC and am building a website to understand and report this. I believe that Roger Simons was probably murdered with a political motive. I have no evidence of this, however I have mass of evidence that identifies deceit, misrepresentation, failure to follow council protocol and 3 instances of a breach of a major environmental law with associated deaths nearby that completes the requirements for a Corporate Manslaughter investigation. Documents produced to identify this by our group have been destroyed by serving councillors prior to reaching the council clerk.

People are dying unnatural deaths in this area and we are living next to a toxic waste dump that is confirmed as toxic but is deliberately misrepresented by NPTC. Toxic waste is lying on the surface after being spread by the developer Enzo and nothing is being done about it. The local councillors are lying to the public about this and are also lying to the public about having meetings with Public Health Wales . A FOI to PHW shows that no meetings have taken place. I have clear evidence of this. A chemical test of the toxic waste area can be clearly seen to have been tampered with and reports of barrels of toxic waste being tipped at the site are not investigated. Both regualtory authorites NRW & PHW refer our group back to NPTC Planning who it would seem are a self regulating authority who refuse to investigate our concerns use methods of deception to avoid accounatbility for their crimes.

We, as a community desperately need the police to investigate this please and to allow us, the Glynneath Residents Against Contamination group to work with you in the provision of relevant information and pointers to misconduct incidents.

Dear DS Peach, In your initial response you do not make mention of the following information supplied to you.

I provided this information to make you aware that the initial post containing the video is on a social media site that is run Mike Pugh and/or his supporters. The post mentions the election and is clearly intended to influence the election. It does not however, contain an imprint of any kind which is an election offence.

I do apologise if I didn't make this information clear in my initial complaint, I only mentioned the copyright issues so that your focus was on the election offence relating to the initial posting of the video without the appropriate election protocol. This is what confused me when you mentioned Youtube.

Dear DS Peach - thanks you for your reply which is clear and concise. However, there is one thing I am confused about and that is you mention Youtube. The video uploaded to the facebook page is currently not on Youtube. It was only uploaded for a couple of days in October 2020 and then removed from that site and has not been shared on any platform since then. This means that the video uploaded to the facebook page has been stored on someone's computer hard drive since last October or has been shared to the person who uploaded it on Glynneath Neaws & Views Unbiased. I just wanted to point this out just in case it makes a difference to your investigation. - Dai.

Good Morning Mr Richards

South Wales Police Economic Unit deal with all allegations relating to Electoral Malpractice.

With regards to you brining this matter to our attention , I have had a look at the material and together with the footage posted on YouTube.

You make mention 'breached election rules and protocol by publishing a video of myself on a social media page without my consent. Although technically the publishing of the video is a civil matter, the content of the post does not match the intention of the video and because the video was never intended for public viewing it has generated a number of adverse comments that have proved to be quite distressful for myself and family'.

A number of person have commented on the video, expressing their opinions/ responses to the video.

With the information you have provide me, no electoral offence is evident at this stage.

However other media/social media outlet rules may have been breached.

With regards to Facebook, I would provide the following guidance as per their website;

What rights do I have as a copyright owner?

As a copyright owner, you have certain rights under the law. These include the right to stop others from copying or distributing your work, or from creating new works based on your work. Copyright infringement generally occurs when a person engages in one of these activities without the copyright owner's permission.

For example, when someone uploads your photo or video, they make a copy of that photo or video. The same is true if someone uses a song in the soundtrack to a video, even if they paid for a copy of that song on another service.

If you own a copyright, you have the right to grant permission to use your copyrighted work as well as the right to prevent other people from using your copyrighted work without permission.

How do I report copyright infringement on Facebook?

If you believe someone is infringing your copyright, you can report it to us by filling in this form. You can also contact our designated agent. If you contact our designated agent, please make sure that you include a complete copyright claim in your report.

Before you submit a report of copyright infringement, you may want to send a message to the person who posted the content. You may be able to resolve the issue without contacting Facebook.

The first rule of copyright

That means that they should not upload videos that they didn't make, or use content in their videos that someone else owns the copyright to, such as music tracks, snippets of copyrighted programmes or videos made by other users, without necessary authorisations.

What action does YouTube take for copyright infringement?

If a copyright owner submits a valid DMCA (Digital Millennium Copyright Act) complaint through our webform, we take down that video and apply a copyright strike. If a user gets three copyright strikes in 90 days, their account, along with any associated channels, will be terminated. We also have tools to help creators resolve their copyright strikes – including waiting for it to expire after 90 days, requesting a retraction or submitting a counter notification.

Content ID works differently. If a match between a reference file and a new upload is found, a 'claim' is made. Based on the preference selected by the Content ID owner, we'll apply a policy to track, monetise or block, but will not issue a copyright strike.

The key element to 'probably murdered' is that he has been missing for 6 months and his body has not been found, Roger was knocking on in age and rarely strayed off the path when walking which would suggest that if he had died naturally his body would have been found by now. This is empirical evidence of course. Based upon my knowing Roger and I knew Roger quite well, he would visit me at my home and I would feed him information. This made him many enemies because the information I fed him would identify corruption or deception within the councils. Roger was a political animal and a people watcher, he also had an in depth knowledge of the political sytem including the election day process. His downfall as a politician was that he was computer illiterate. You must forgive me being a bit sceptical here but I'm an analyst by nature and have supplied information to the police on at least 5 occassions relating to corruption within government and there does not seem to be an interest in bringing government officials to justice even if they are blatantly dishonest. Following my reports, the police either ask the wrong questions of the wrong people and then block me or just block me from the start. To return to our previous communication, potentially if you had investigated the Mike Pugh offences properly, then maybe Roger would still be here. You were given the information and failed to liaise with me to investigate it properly, you failed to chase it back to its source which is potentially the same people that have murdered Roger, 'probably'. They are the people who need to keep me out of government because I will ask them the right questions for the benefit of the community that will impact on their corrupt activities within government. Roger was the same, he asked the right questions for the right reasons. I can see from your reply that I'm wasting my time with you again and with South Wales Police in general. I don't want to waste your valuable resources any more. Have a nice weekend. R.I.P Roger, wherever you are. - Dai
