The attached document / letter from NRW was sent to us after we supplied them with documents containing the attached 'cause' and 'effects' of the rare deaths of the residents in our street (see attached) as suggested by PC Richard Blake. NRW point our group back to NPT Council who have caused these deaths and are covering up this offence. They are the regulatory authority and it is their responsibility to investigate these deaths..

I also attach a letter from the Glynneath Town Clerk showing how two serving Glynneath Councillors have disposed of the PSP report instead of investigating or passing on to the relevant authority which in this case is Public Health Wales.
